The Adhoc Committee will also supervise the performance of the Coach Shri Indrajit Ghosh.

Payments will be made directly to the vendor/person concerns for making the expenditure.

This Adhoc committee will function for the interim period till constitution of regular committee and further order as may be necessary.

The Adhoc committee will coordinate for constitution of the regular committee of Kanchanpur Cricket Association within 60 (sixty) days and report to the Secretary, TCA.
